### **Background to the Study**

Laois County Council, along with OPW, appointed JBA Consulting and JB Barry & Partners to assess, develop and design an appropriate, cost-effective, and sustainable flood relief scheme which aims to reduce flood risk to Mountmellick.

## Progress to date (May 2021 - Aug 2023)

A project website has been set up and is available at <a href="www.mountmellickfrs.ie">www.mountmellickfrs.ie</a>. Project updates, timescales and published documents will be made available here along with information on past and upcoming events.

Environmental surveys have been carried out and their findings have informed

the AA Screening and EIAR Scoping Reports. These included the installation of cameras at Owenass Bridge which confirmed the presence of otters. The Site Investigation works have been completed and the ground conditions confirmed allowing us to determine the



appropriate form of flood protection - a flood embankment or a flood wall. A Heritage Survey has been completed to identify local heritage features and how they will impact on the design of the scheme. An assessment of the capacity of Owenass Bridge has confirmed that it will have to be replaced by a structure with a wider span to ensure the integrity of the structure.

A detailed analysis of each option was undertaken assessing both positive and negative impacts of each option in a range of areas including environment, public feedback, cultural heritage, archaeology and biodiversity among others. The outcome of this assessment was the identification of a preferred option. This allowed the preferred option to be progressed and the development of preliminary design drawings, photomontages, and buildability considerations.

## **Preferred Option**

The scheme is currently in the preferred option development phase. The project previously presented three scheme options to the public at a virtual Emerging Options Engagement event in April/May 2021. Based on the feedback received at this event, along with other key considerations, a preferred option was identified and is currently being progressed to the planning stage.

The proposed scheme will be designed to protect against a 1 in 100-year event and will take appropriate account of the unique flow conditions that are experienced in Mountmellick and the interaction between the Owenass and the Pound.

#### **Public Participation**

Brochures and questionnaires were distributed as part of the initial public consultation event for the flood relief scheme. There was a positive response received which provided valuable insight into previous flooding mechanisms and issues throughout Mountmellick.

A virtual Emerging Options Engagement event was held in April/May 2021. Once again there was a positive response received along with valuable feedback which aided in the identification of a preferred option.

We now invite you to participate in the final Public Information Day ahead of the planning submission, which will be held at the Mountmellick Development Association (MDA), Mountmellick, Co. Laois on **Tuesday 12**th **September 2023**. This event is open to all residents, businesses, organisations and other interested parties. On the day, the project team will be present to provide details of the preferred option, answer questions and give you the opportunity to share your thoughts on it.
